

The Humboldt Library Foundation is pleased to announce they have selected former Humboldt County Supervisor and founding Board Member of the HLF, Bonnie Neely to receive the 2011 Helen Everett Award.

Bonnie was elected to the Board of Supervisors in 1987 and immediately became an advocate for the new Main Branch Library in Eureka. She worked closely with Library Co-Chairs Elizabeth Murguia and Sally Upatisringa on the location and fundraising for the new library.

"My story in connection with the Humboldt County Main Library is a celebration of people in action. If you ever need an example of how to move an agenda through a bureaucratic process – the library is your model."

Bonnie was introduced to the library by her mother Edythe Neely. Mrs. Neely took her son, Geoffrey, and four daughters Bonnie, Colleen, Linda and Kelly to the Carnegie Library every week. "Those were great times," Neely said. "My parents valued education."

"As a student at Eureka High School, my education regarding the need for a new library facility in Eureka came from my girlfriend Gretchen's mother – her name was Janie Walsh. In my twenties, I took up snow skiing and often went with a local family. A member of that family had a particular passion for a new Eureka branch library on the waterfront. Her name was Nancy Hilfiker. By the time I was elected to the Board of Supervisors, I knew why we needed a new library and where it should be located."

The challenges facing the building of our Main Branch Library were numerous: the library bond measure which provided over \$9 million to Humboldt County for library construction, the library site selection - Myrtle & 7th Street location versus the Eureka Waterfront which resulted in litigation, and fundraising for the required local match in the amount of \$2 million. "I especially loved the read-a-thons staged by elementary school children from all over Humboldt County. Local kids can proudly point to this library and say, I read books and raised funds to get this library built!"

The Helen Everett Award was established to recognize individuals or organizations whose contributions improve the quality of public library services in Humboldt County. Bonnie is the 14th recipient. Please join us in honoring Bonnie Neely at the HLF Annual Holiday Gala which will be held Monday, December 5, 2011, at Baywood Golf and Country Club. Every week, just like clock-work, I receive a letter from my child-hood friend who lives in Massachusetts. We've been writing on and off to each other for the past 45 years. But since her retirement, Cynthia has decided she should write to me

every week. She says not to worry - I don't need to respond to each letter. I do worry because my record of response is not as frequent as I intend. However, we do it, make the commitment, pull out a piece of paper and word process a letter, put a stamp on it and mail it. Very old-fashioned – not email. But I notice, even after all these years, we still write the same type of letter, just as we did when as young moms we couldn't afford the cost of a phone call. It goes like this: observations of places visited, some political comment, kid update, garden talk and then we launch into what we've just read and what we recommend to each other. Now granted, Cynthia is way ahead of me. If life is the book-list we need to read, she is way ahead. Now, she watches Book Notes and promptly reserves the most intriguing at her public library in Lowell, thrilled that she 'owns' them already.

In my travels this summer, my reading was inspired by place. I made it to Archer City, Texas to check out Larry McMurtry's remarkable book store(s) - Booked Up 1, 2, 3 and 4. Four hundred and fifty thousand volumes at last count, which attests to a man with a passion for books. It was overwhelming, but fascinating. In my trek across the country, and before Archer City, my friend and I detoured to Marjorie Kinnan Rawlings home in northern Florida. It is now a state park with Rawlings' home and gardens intact. The park interpreters were especially pleasant and well informed (it reminded me to take the time to visit Jack London State Park in nearby Glen Ellen). I have not re-read the Yearling, but enjoyed "Cross Creek," her memoir of neighbors and place. When I was in Italy in June, I found the "Pope's Ceiling" helped to interpret Rome, and in Florence, "the Artist, the Philosopher and the Warrior" (Da Vinci, Machiavelli, and Borgia) enhanced my experience in that beautiful Renaissance city. And as I headed toward the Grand Canyon and a rafting trip on the Colorado River, John Wesley Powell's remarkable exploration of the west as written by Wallace Stegner in "Beyond the Hundredth Meridian", opened up whole new vistas and history for me.

Libraries: At the State Library Board meeting in August, there was much discussion about the impact of the digital age on libraries – how will libraries look in the future? Will there be books or will everyone carry a Kindle? If books are free (through the ether), how do we ensure there are future writers and publishers? All intriguing questions and possibilities. But with the explosion of information, the public library remains a place of trust and source of information – a clearing house and a reference station. My friends vacationing on Swan's Island off the coast of Maine just called – they visited the new library: complete with a fireplace and screened porch. It seems, in spite of the challenges of funding and future, libraries remain the place of refuge and inspiration. Thank goodness.

LOCAL AUTHOR'S CORNER — AMY STEWART

Amy Stewart moved to Eureka with her husband, Scott Brown, the same week her first book was published. Ten years later, she is the award-winning author of five books on the perils and pleasures of the natural world, including three New York Times bestsellers, Wicked Bugs, Wicked Plants and Flower Confidential. She and Scott, a rare book dealer, bought Eureka Books in Old Town in 2007 and run it with the help of their business partners, Jack and Peggy Irvine, and three employees.

Amy isn't found behind the counter of the bookstore much, however. She travels the country speaking to audiences at college campuses such as Cornell and the University of Minnesota, corporate offices, including Google's Mountainview campus, conferences and garden shows, as well as botanical gardens, bookstores, and garden clubs nationwide. She has also appeared on hundreds of national and regional radio and television programs, including CBS Sunday Morning, NPR's Morning Edition,



Fresh Air, and Good Morning America. She has written for the New York Times, the San Francisco Chronicle, and every national garden magazine, including Fine Gardening, where she is a contributing editor. Locally, she also writes for the North Coast Journal.

"My books are on somewhat unusual subjects," she said. "Poisonous plants, venomous insects, the global flower industry, earthworms--I'm lucky to have a publisher who is open to my ideas, and willing to let me go explore my interests. For me, these books are all about the people, and all about storytelling. <u>Wicked Bugs</u> and <u>Wicked Plants</u> in particular are really less about bugs and plants and more about poison, murder, and mayhem.

In the last few years, Amy has been awarded a National Endowment for the Arts fellowship, the American Horticulture Society's Book Award, and a California Horticultural Society Writer's Award.

Her five books include From the Ground Up: The Story of a First Garden, The Earth Moved: On the Remarkable Achievements of Earthworms, and the New York Times bestsellers Flower Confidential: The Good, the Bad, and the Beautiful in the Business of Flowers: Wicked Plants: The Weed That Killed Lincoln's Mother & Other Botanical Atrocities: and, most recently, Wicked Bugs: The Louse that Conquered Napoleon's Army and other Diabolical Insects.
