## EXECUTIVE ORDER SLASHES INSTITUTE OF MUSEUM AND LIBRARY SERVICES / GRANTS TO LOCAL LIBRARIES

The Institute of Museum and Library Services (IMLS) is an independent federal agency that supports libraries, archives, and museums in all 50 states and U.S. territories. Created in 1996, IMLS is the federal government's source of support for these local institutions, with a total budget of \$290 million—\$160 million of which goes to state library agencies

that in turn is competitively grant funded to local libraries to support operations, construction projects, early literacy development, summer reading for kids, access to high-speed internet, and more.

A March 14 Executive Order decreed that the IMLS be "eliminated to the maximum extent consistent with applicable law." On March 31 the administration placed the entire IMLS staff on leave for up to 90 days, a move that will prevent 2025 grants from being reviewed and processed.

Deputy Secretary of Labor and newly appointed IMLS acting director, Keith Sonderling said, "We will revitalize IMLS and restore focus on patriotism, ensuring we preserve our country's core values, promote American exceptionalism, and cultivate love of country in future generations."

While our Humboldt County libraries have benefitted from IMLS grants, including the recent establishment of the "Library of Things" at the Hoopa Branch, we will not experience a devastating impact from these actions. The same

cannot be said for other libraries throughout our country. Some rural libraries will close. Our library system will continue to operate and even thrive, in large part due to your support of the Humboldt Library Foundation. HLF's commitment to our libraries is stronger than ever.

We encourage you to let your legislators know that libraries are a priority for you, that they are here not to tell just one story, but to tell everyone's story.

We also remind you to visit your local library, thank a librarian or staff member for their work, check out a book, attend a movie night or join a book club. Make USE of this vital institution—it is all of ours to enjoy and benefit from.




I encourage you to seek out this compelling documentary and experience for yourself the optimism and invigoration it provided me.

Humboldt County Library is pleased to announce the appointment of the new Library Senior Assistant for the Acquisitions and Technical Services Division, Althea Christensen. Althea's appointment comes after a search that yielded many highly qualified candidates. Althea

worked as a Library Assistant I/II for the Humboldt County Library since July 2022. As a cataloger, Althea has completed additional training in cataloging videos, maps, 3D objects, and graphic novels. ### EUREKA BOOKS DONATES ONE PERCENT OF CASH SALES TO HLF

Everyone knows that shopping locally is the right thing to do, but savvy shoppers take an extra step and pay with cash. Paying with cash saves local businesses thousands of dollars each year, keeping that money in the local economy. One small business has decided encouraging cash payments can be a benefit to his store and to the Humboldt County Library.

"When I bought Eureka Books three years ago I looked into ways to cut expenses. Credit card fees were an obvious place to start," Solomon Everta reports. Even before the COVID-19 pandemic credit card usage was on the rise but in 2020 use of cash dropped precipitously. "This is an important issue for small businesses," said Everta, "I was even invited by a bookselling trade group to go to Washington, D.C. to testify about how these fees are impacting small businesses, but it's not just booksellers – it's all retailers." Everta was not able to make the trip, but continues to share what he has learned.

After changing card processing providers and getting his

fees down to around 4% of each credit card sale, Everta worked on getting more people to stop using credit cards altogether. "At the bookshop I have little signs at the registers explaining that 1% of cash sales will be donated to the Humboldt Library Foundation. It's an easy way to start the conversation about exorbitant credit card fees."

At the end of every year, as Everta is working with the rest of the Humboldt Library Foundation Board planning the annual Gala for the Library he calculates total cash sales at Eureka Books in the last year. One percent of that amount is donated to the Foundation.

"It really is a win-win situation," said Everta. "I get to talk about supporting small business and supporting the Humboldt County Library. My customers get to choose to support both institutions. So, bring some cash, the next time you go shopping!" Keeping Everta's suggestion in mind you can support local small businesses and you just might end up supporting the Library, too.

## HAPPY 25<sup>TH</sup> BIRTHDAY TO THE SERENDIPITY BOOK STORE!

Serendipity Book Store, "The Little Store on the Second Floor" of the Eureka Main Branch library, celebrated its 25th birthday not long ago. Since Friends of the Redwood Libraries opened the store in the Fall of 1999, Serendipity has raised over \$630,000 for the benefit of the library.


Customers love the great prices – most books are \$2 and children's books are even less. There are also quite a few items like greeting cards, maps, sheet music and ephemera for just 25 or 50 cents. New stock comes into the store every week and display tables change often - savvy customers come in weekly to check the new arrivals shelves. The local

history shelf is especially popular, and books in that section may sell within hours. Serendipity stocks best sellers and classic favorites, but also older and more unusual books. It isn't uncommon for customers to tell volunteers "I always find something great here!" as they make their purchase.

## WRIGHT'S RECOMMENDATIONS


"Orbital" by Samantha Harvey: I couldn't stop reading this short, beautifully written Booker prize winner. Set over a 24-hour period on the space station, 250 miles above earth, this book is told through the eyes of six international cos-



monauts as they go about their daily routine. Chie, for example, works with rats, apologizes to them for their discomfort, and often thinks about her mother's passing while contemplating life without her. I loved the descriptions of eating, exercising, and doing research in space. I appreciated the way the characters each pondered life and mortality as they looked at the earth from so far away. From space it's a land with no borders

or boundaries—a living, breathing, beautiful place. I loved this beautiful, immersive book told over the course of the 16 sunrises and 16 sunsets that take place over a 24-hour period. And it made me love our planet even more.

HLF Board member Erika Wright is a voracious reader who doesn't limit herself to any one genre. Her book recommendations at board meetings have proven delightful and we are so pleased to share some with you here.



"Butter - a novel of food and murder" by Asako Yuzuki: I enjoy international translations and the peek into a different world view. This story was inspired by a real person (the Konkatsu Killer) - a Japanese foodie who was convicted of seducing and poisoning three businessmen. It begins when a journalist (Rika) secures an interview with Manako Kajii by asking her for her beef stew recipe. Mana-

ko refuses to speak about the case, but instead sends Rika on food adventures. A strangely intimate relationship with complicated power dynamics develops between the two women as Rika becomes obsessed with following Manako's life and culinary experiences. This story is rich in so many ways, not only in its descriptions of food, but also as a societal critique—particularly of the impossible, sometimes competing expectations of women—from beauty standards, to fatphobia, and expectations of marriage and children—all from a decidedly Japanese perspective. The story also illustrates various forms of friendship that defy rigid social norms.
